1. ON SEPTEMBER 10, 2004 AT APPROX. 0125 HRS. THE UNDERSIGNED ALONG WITH DET. HABERT INTERVIEWED [REDACTED] AT THE 66 DETECTIVE SQUAD. [REDACTED] HAD INDICATED TO HIS ARRESTING OFFICER THAT HE HAD INFORMATION REGARDING THE MURDER OF MARK FISHER. [REDACTED] STATES HE DID NOT WITNESS THE MURDER NOR DID HE SPEAK WITH ANYONE INVOLVED IN THE MURDER. HE HAS HEARD FROM FRIENDS IN HIS NEIGHBORHOOD THAT A GUY HE KNOWS BY THE NAME OF "TWEED" DID THE MURDER. HE THINKS THE MURDER HAPPENED ABOUT ONE YEAR AGO. IT WAS A FEW WEEKS AFTER THE MURDER THAT HIS FRIENDS STARTED TALKING ABOUT THE MURDER AND THAT "TWEED" DID IT. HE REMEMBERS READING ABOUT THE MURDER IN THE PAPER AROUND THE SAME TIME. [REDACTED] STATES HE KNOWS "TWEED" FOR ABOUT TWO OR THREE YEARS. HE KNOWS THAT HE LIVES OFF THE CORNER OF TURNER PLACE AND STRATFORD ROAD. HE DESCRIBED HIM AS A MALE BLACK, LIGHT SKINNED, APPROX. 19 YEARS OLD, 5'8", 170 LBS. HE STATED HE USE TO HAVE BRAIDS IN HIS HAIR BUT THAT A WHILE BACK HE CUT HIS HAIR SHORT. HIS FRIENDS TELL HIM THAT "TWEED" KILLED THE GUY WHILE HE WAS TRYING TO ROB HIM. I WAS TOLD THAT HE LEFT FOR CALIFORNIA AFTER THE MURDER BECAUSE HE WAS AFRAID HE WAS GOING TO BE ARRESTED. [REDACTED] DOES NOT KNOW THE EXACT LOCATION WHERE "TWEED" KILLED THE GUY. HE JUST HEARD THAT THE KID WHO WAS KILLED WAS AT A PARTY WITH "TWEED" AND SIX OTHER FRIENDS AND "TWEED" KILLED HIM LATER THAT SAME NIGHT WHEN HE TRIED TO ROB HIM. [REDACTED] STATES HE DEALS WEED AND THAT "TWEED" HAS BEEN ONE OF HIS CUSTOMERS FOR A FEW YEARS. HE STATES "TWEED" WILL USUALLY CALL HIM AT HOME AND THAT THEY MEET ON EAST 8TH ST. AND BEVERLY ROAD TO MAKE THEIR DEALS. HE STATES THAT "TWEED" IN A CRIP GANG MEMBER. "TWEED" HANGS OUT WITH A GUY BY THE NAME OF "SCOLD". "SCOLD" LIVES ON EAST 5TH ST. BETWEEN CATON AVENUE AND ALBERMARLE ROAD. "SCOLD"'S BROTHER "LEFTY" IS A FRIEND OF [REDACTED] HE STATES "SCOLD" JUST GOT OUT OF RIKER'S ISLAND ON A PROBATION VIOLATION. "SCOLD" IS A GOOD FRIEND OF "TWEED" AND [REDACTED] STATES THAT HE MIGHT HAVE INFORMATION ABOUT THE MURDER. [REDACTED] STATES APPROX. TWO MONTHS AGO HE SAW "TWEED" ON CORTELYOU ROAD AND EAST 3RD ST. AND THAT "TWEED" SHOWED HIM A GUN IN HIS WAISTBAND. "TWEED" LIFTED HIS SHIRT AND STATED "I GOT MY RATCHET" [REDACTED] DESCRIBED THE GUN AS A .22 OR .25 CALIBER BLACK AUTOMATIC. [REDACTED] STATES HE TRIED TO BRING UP THE MURDER IN CONVERSATION ONE TIME WITH "TWEED" BUT HE DID NOT TALK ABOUT IT. HE STATES "TWEED" JUST LEFT WITHOUT SAYING A WORD. [REDACTED] STATES HE DOES NOT HAVE ANY OTHER INFORMATION THAT MAY AID THIS INVESTIGATION.

SUBJECT: : INTERVIEW OF JONATHAN CARDONA, D/O/B 10/22/84 M/HISP

1. On 9/16/04 Det Byrnes and I interviewed Jonathan Cardona (Mr Cardona received telephone calls from Antonio Russo) inside our RMP while driving around the area of Crystal Valentin's residence and the v/o Beverley Rd and Coney Island Ave .

2. Jonathan Cardona stated that he had dated Crystal Valentin for approx. 10 months 3/03-2/04. In Aug/03-Sept/03 a unknown male (who he later learned to be Tony Russo) left a message on Jonathan Cardona's voicemail. This male left a threatening message saying he was going to kill Jonathan Cardona if he didn't stop messing around with his girlfriend. This male also stated that he had a burner and that he was going to bust a cap in his ass. Then about a week or two later (Sept/03) Jonathan Cardona is working in McDonalds ([REDACTED]) he received a call from the same male (Tony Russo) . This male again threaten Jonathan Cardona in regards to his girlfriend (Crystal Valentin). Jonathan Cardona tells him to come to McDonalds and that he gets off at 8pm. This male tells Jonathan Cardona to come to his neighborhood and that he got boys. This male also again mention that he had a burner and threaten to kill him. This male also left a voicemail earlier in the day that was similar in nature. Jonathan Cardona confront Crystal Valentin by phone and at first Crystal Valentin denied knowing the guy . Crystal Valentin then stated that the guy name was Tony. Jonathan Cardona then stated in Oct/03 he accessed Crystal Valentin's cell voicemail and heard a voicemail from Tony . Tony left a message of a sexually explicit nature of things he has done to Crystal Valentin. Then Jonathan Cardona calls Crystal Valentin and leaves a message for Crystal Valentin about her cheating. Then a short time later Tony calls him and told him that his name was Antonio . Tony tells him that Cystal Valentin is cheating on him with about 9 other men. Jonathan Cardona and Tony work out their prior telephone beef. A couple of days later Jonathan Cardona calls another one of Crystal Valentin's boyfriends he believes his name was Jeffrey. Jonathan Cardona leaves a message on his voicemail that Crystal Valentin is cheating on him (Jeffrey) and asked for him to call him back.

SUBJECT : INTERVIEW OF JONATHAN CARDONA

A friend of Jeffrey calls Jonathan Cardona and tells him that Crystal Valentin is Jeffrey's girlfriend and that she come with a friend of her to see Jeffrey in the Bronx. Jeffrey calls Jonathan Cardona the next day. Then Jonathan Cardona telephoned Tony Russo and the three of them start a three way call. the three agreed to meet the next day a Crystal Valentin's residence at 9:00am. Jonathan Cardona arrive at Crystal Valentin's at 11:00am and see that all the windows in the front were broken. Jonathan Cardona calls Crystal Valentin. Crystal Valentin tells Jonathan Cardona to leave that she doesn't want Anthony to hurt him. Jonathan Cardona goes home and calls Crystal Valentin. Tony Russo pick up the telephone and asked who was this. Jonathan Cardona could hear a struggle over the telephone and the telephone discount. Jonathan Cardona calls Crystal Valentin's residence several times and there was no answer. Jonathan Cardona calls Tony Russo's cell phone. The two agreed to meet in f/o Crystal Valentin's residence. Jonathan Cardona arrives at Crystal Valentin's residence between 4-5pm outside the house is the porter Ralph who he has seen before calls out for Crystal Valentin. Jonathan Cardona hears like something thrown against the wall. Tony Russo come out of her residence and Tony Russo is limping Tony Russo tells Jonathan Crystal stabbed him in the foot. Tony Russo tells Jonathan Cardona that he fucked Crystal Valentin so hard that he killed the baby. The two leave Crystal Valentin's residence and travel e/b on Beverly Rd. They see a kid(m/blk, 18y/o)with a blue bandanna walking, Tony Russo asked the kid if he was Crip. The kid didn't say anything and continued walking. Tony Russo starts talking about Jeffrey and tells Jonathan Cardona that Jeffrey went crazy when they met and Jeffrey broke the Crystal valentin's windows. Tony Russo also stated that he invited Jeffrey over to his residence and the two were smoking weed. **Tony Russo then tells Jonathan Cardona that he stuck a gun in Jeffrey face. Jeffrey started crying. Tony Russo also stated that he threaten to kill Jeffrey.** Tony Russo and Jonathan Cardona continue to walk up Beverley Rd to an light colored apt bldg where the front of the bldg is set back from the side walk. On the stoop is a m/blk , 5'9" , med blt wearing a black jacket and also a black du-rag. this male was holding hands with a girl (possibly a f/hisp , early 20, 5'9" , stocky blt). Tony Russo give the male a hand shake. Tony Russo tells the male that he got another one for you. The male tells Tony Russo that you got to stop doing this it's getting crazy. Tony Russo then said that I take care of by own business. The female then leave and got into the bldg and tells the that she wanted to go upstairs. Jonathan Cardona stands to the side while Tony Russo and the male begin to talk. The male tells Tony Russo I got to talk to you later, you know what it is. Tony Russo said alright. Then Tony Russo and Jonathan Cardona leave , Jonathan Cardona isn't sure if Tony Russo stopped for cigarettes before or after they stopped at the bldg where the male was. But they started walking n/b on Coney Island Ave from Beverley Rd. Tony Russo calls Crystal Valentin. Jonathan Cardona could hear Crystal Valentin over the phone telling Tony Russo that she was calling the police. Tony Russo tells her that he didn't do it. Tony Russo give the phone to Jonathan Cardona. Crystal Valentin tells that she doesn't want to talk. Tony Russo repeatedly tells Crystal Valentin that he didn't do it. Then Crystal Valentin then hung up the phone. they then made a right from Coney Island Ave. Tony Russo begin to talk to a 4-5 male blacks and Hispanics (8-12y/o) on bicycles. They asked Tony Russo why he was limping Tony Russo tells them that the bitch stabbed him. The kid told him that he was lying and rode away. Tony Russo asked Jonathan Cardona if he wanted to come to his residence. Jonathan Cardona asked Tony Russo where the nearest subway was. Tony Russo gave him direction to the Q-line. Jonathan Cardona decided to go back to the F-line. Later that day Tony Russo called Jonathan Cardona and asked Jonathan Cardona what train he took. Jonathan Cardona told him that he took the F. Tony Russo told him that he should have taking the Q it was better . Tony Russo calls several other times for week , but Jonathan Cardona didn't return any of his calls.

3. Crystal Valentin calls Jonathan Cardona early Nov/03 after the Marathon. Crystal valentin asked if he saw the newspaper from yesterday . Jonathan Cardona tells her no and asked her why. Crystal valentin tells him that Tony Russo is in the paper. Jonathan cardona checks on the internet and find the article. Jonathan Cardona calls back Crystal Valentin and tells her that he found the article. **Crystal Valentin tell Jonathan Cardona that Tony Russo did it. Jonathan Cardona asked her why she thought that. Crystal Valentin stated that just the way he is.** Jonathan Cardona then began to check Crystal Valentin's cell phone bills on the internet and voice mails and could see that was still calling her.

MR. ROMERO DID NOT KNOW WHY TONY SAID HE WAS STRESSED OR HAD PROBLEMS. TONY DID NOT SEEM TO BE MAKING ANY SENSE WHEN SPEAKING. MR. ROMERO THEN ASKED TONY WHY HE CUT HIS HAIR. TONY REPLIED "IF THE KID DID NOT GET STUPID, I WOULD NOT BE IN THIS PREDICAMENT". AT THIS POINT ME AND DAMIEN REALIZED THAT TONY WAS TALKING ABOUT THE KID WHO WAS MURDERED AND THAT HE WAS THE ONE WHO DID IT. I THEN TOLD TONY THAT I SAW TWO DETECTIVES ALONG WITH THE SEWER PEOPLE CHECKING A SEWER ON STRATFORD ROAD. AND BEVERLY ROAD FOR EVIDENCE. HE SAID THAT'S GOOD, THEY CHECKED FOR EVIDENCE IN THE WRONG SEWER. I DID NOT THROW TWO THINGS IN THE SAME PLACE. THEY CHECKED THE WRONG ONE". I HAD ALREADY SEEN IN THE NEWSPAPERS THAT THE POLICE RECOVERED HAD FOUND THE KIDS WALLET IN A SEWER WHEN WE HAD THIS CONVERSATION. TONY NEVER STATED WHAT WAS THROWN INTO THE SEWER. I ASKED HIM IF HE THREW ANYTHING BY "CRIPS" HOUSE. I WAS REFERRING TO THE GUN BECAUSE I THOUGHT TONY ALREADY KNEW THAT A WALLET WAS FOUND. TONY JUST SMILED AND SAID "MAYBE". "CRIP" IS A MALE BLACK, APPROX. 18 yrs. OLD, WHO LIVES IN A BLUE HOUSE BETWEEN ARGYLE ROAD AND RUGBY ROAD ON BEVERLY ROAD. AT THIS POINT IN THE CONVERSATION TONY'S FRIEND CAME UP AND ME, TONY AND DAMIEN STOPPED TALKING. TONY THEN LEFT WITH HIS FRIEND. ME AND DAMIEN HAVE TALKED ABOUT COMING TO THE POLICE WITH THIS INFORMATION FOR AWHILE BUT WE WERE AFRAID. MY BOSS FINALLY ENCOURAGED ME TO COME IN. MR. ROMERO FEELS DAMIEN WILL DENY HEARING TONY TALK ABOUT THE CRIME BECAUSE HE WILL NOT WANT TO GET INVOLVED.

4. MR. ROMERO STATES THAT HE HEARD THAT TONY FLED TO CALIFORNIA A DAY OR SO AFTER THE MURDER. I DON'T REMEMBER WHO TOLD ME THIS, BUT EVERYONE WAS TALKING ABOUT IT.
5. ON MARCH 27, 2004 AT APPROX. 1243 HRS. ALEJANDRO ROMERO WAS SHOWN A PHOTO OF ANTONIO RUSSO AND HE POSITIVELY IDENTIFIED HIM AS THE MALE HE KNOWS AS "TONY".
